NOTES

1. NC legislation requires that educators take all exams in the first year of licensure and pass by the end of the third year of licensure.
2. Candidates with lateral entry or residency licenses must pass all required exams in order to clear their license after graduation. The three-year testing window does not apply.
3. edTPA must be successfully completed during the student teaching internship.
4. A grade of P in the student teaching internship is required for graduation and licensure recommendation.
5. Assessments phasing out will continue to be accepted by NCDPI to satisfy testing requirements for three years beyond the last date offered.
